Learn Well: Creating Psychological Safety in the Clinical Learning Environment

This interactive workshop will bring together participants to discuss best practices in creating psychological safety for learners in order to enhance well-being in medical training. Participants will develop a broader understanding of methods for enhancing psychological safety and create a personalized action plan including three specific practices to promote psychological safety in the learning environments in which they work and teach. This workshop addresses both undergraduate and graduate medical education accreditation standards which require programming to promote well-being, which is directly related to psychological safety in the clinical learning environment.

Learning Objectives:

- 1. Define psychological safety as it relates to the clinical learning environment.
- 2. Identify the relevant program requirements related to psychological safety in the undergraduate and graduate medical education.
- 3. Identify available opportunities to enhance psychological safety in the clinical learning environment, including critical incident debriefing and psychological first aid.
- 4. Develop an action plan for participants to apply new knowledge/skills to learning environments in which they work.

An Interdisciplinary Team Approach to Developing Entrustable Professional Activities (EPA) for Assessing Common Tasks: A Case Study

This workshop will outline the steps involved in the development of a collaborative, cross-cutting, interprofessional teamwork EPA used by addiction medicine and addiction psychiatry fellows, as an example. The facilitators will explore tasks performed by trainees that may be broadly applicable to training programs in different disciplines and how EPAs can be used by different disciplines to assess entrustment of emerging subspecialists.

- 1. Compare and contrast assessment tools used to evaluate specific and actionable clinical skills vs. broad evaluation domains.
- 2. Examine the use of EPAs as an assessment tool for subspecialty fellows in training.

Metacognition and Critical Reflection in Supervision: A Workshop for Educators

Current approaches to clinical supervision are insufficient to address tensions and challenges related to power, hierarchy, and personal/professional identities. Metacognition and critical reflection can be effectively integrated into supervisory practices to enhance shortcomings of current approaches. This workshop is informed by transformative pedagogy. The facilitators will review existing approaches to clinical supervision and critical reflection and lead discussion on literature on metacognition and provide clinical supervisors with guidance on how incorporating reflection of self-experience can heighten awareness of internal processes including potential biases and stigmatizing beliefs that influence the enactment of supervision.

Learning Objectives:

- 1. Provoke critical reflection among clinical supervisors on their own supervisory practices
- 2. Review existing approaches to embedding metacognition and critical reflection into clinical supervision.
- 3. Provide examples of how supervisors can incorporate metacognition and critical reflection into clinical supervision.
